1. Objectives

- 1.i To carry out a Level I/II, Building Survey to the standards laid down in the English Heritage: Understanding Historic Buildings, A guide to good recording practice, 2006.
- 1.ii This will entail a programme of photographic recording and measurement from photographs and plans supplied by the client.

2. Scope of the work

- 2.i The work will record aspects of both the interior and exterior of the building.
- 2.ii Any structural features of interest will be noted and described.

3. Methodology and Contingency Arrangements

- 3.i A study will be made into any existing information pertaining to the area of the site.
- 3.ii This information may be obtained from appropriate sources such as the Historic Environment Record (HER), Royal Commission on Ancient and Historical Monuments Wales (RCAHMW), Cadw, County Records Office (CRO) and the client.
- 3.iii The measurements will be related to the floor plan supplied by the client's architect.

4. Recording

- 4.i All information will be taken from photographs and plans supplied by the client

6 The Report

- 6.i The report will be fully representative of information gathered from implementation of the Level I/II survey (see Understanding Historic Buildings).
- 6.ii The report will contain at least one location plan showing the site in relation to local topography.
- 6.iii The report will include all drawn sections and plans, with reference to those of archaeological significance.
- 6.iv Once completed, a copy of the report will be submitted to the Torfaen County Borough Council (TCBC), Planning for their approval. Further copies will be deposited with the Glamorgan Gwent Archaeological Trust (GGAT) and The Royal Commission on Ancient and Historical Monuments. Notes of any confidentiality imposed by the client will be included
- 6.v An archive of the work will be compiled with the original retained by A.P.A.C. Ltd and a copy deposited with Gwent County Records Office, Ebbw Vale.
- 6.vi Although there may be a period of client confidentiality, the site archive and report will be deposited with the Gwent Record Office within 6 months.
