SUMMARY The Glamorgan-Gwent Archaeological Trust was commissioned to undertake a watching brief at Hensol Park during the construction of a covered training facility. Some recent drainage features were recorded along with some later post-medieval ceramics and a prehistoric flint waste flake (Sell 2001).

DESCRIPTION The Glamorgan-Gwent Archaeological Trust was commissioned to undertake a watching brief at Hensol Park during the construction of a covered training facility. There was some evidence of levelling consisting of modern deposits. The only features uncovered were a number of stony linear cuts that are likely to represent the physical remains of a fairly modern drainage system. Another linear cut, aligned north-south, could show the remnants of a king furrow or perhaps a recent depression cause by heavy plant (Sell 2001).

The facilities include a two-storey sports pavilion, five pitches and a running track on land at the Vale of Glamorgan Hotel, Golf and Leisure Club, Hensol, Vale of Glamorgan. Two areas of mechanical excavation were observed during which the turf and topsoil was removed. A number of drainage features ralting to the infrastructure of the park were present and were adversely affected by the groundworks for the current development. These included three stone drains and a rectangular, brick-built structure. A single worked flint scraper was recovered. No further archaeological features or finds were recorded.
